**DISCUSSION:** The Mayor identified the purpose of the meeting was to fill councilmember seat vacated by Kathy Hull, effective 4/9/18, and that the selected candidate will take Oath of Office on Wednesday, May 9, 2018, at 3:00 pm in City Hall. A call out to interested candidates was posted on Facebook and in the Star News. Four candidates submitted letters of interest for the seat: William "Bill" James McFarlane of 514 Sawyer Street, Cascade; Candice White, of 305 N Overlook Ave, Cascade; Denise V. Tangen, of 700 Birdie Dr, Cascade; and Jonathon S. Howard, of 955 S Main Street, Cascade. Mayor verified eligibility through the Valley County Elections Clerk. During the previous week, the Mayor held interviews with each candidate. All four candidates possess a unique set of qualifications. All candidates expressed a true desire that Cascade continue to move in the right direction. All four candidates share a desire to make a difference and do their part in support of Cascade's forward progress. The Mayor requested the consent to appointment of Denise V. Tangen to serve until the next general city election in November 2019, at which time this vacancy shall be filled for the balance of the original term through December 31, 2021.
