SNOW and BERMED DRIVEWAYS

On 2/12/2016 this topic was discussed at a City Council Meeting and it was determined that to plow every driveway would not be feasible due to limited staff, budget constraints and fairness to tax payers.

Snow removal at the entrance to or on private property is the responsibility of the property owner.

Did You Know?

Intended for resort destination towns with populations under 10,000, the local option tax provides funds collected from visitors to help maintain utilities, roads, streets, parks and recreation and entertainment venues that experience a higher, seasonal volume of traffic and extra wear and tear to a City's infrastructure.

Funds derived from the collection of a local option tax directly benefit the visitor and resident alike as they support funding pre-established, improvement projects.

A local option tax is not an increase in the cost of a vendor's product; it is an increase in tax that is collected from the customer and remitted by the vendor directly to the City on a monthly basis. The revenue is held in Trust and distributed as established by a City Council or a local option tax commission.
