Grants in progress – the geothermal group will be meeting tomorrow, August 23, 2022. Grant funding is available and will be discussed at this meeting. A letter to Governor Little asking for some of the surplus to be distributed to fund these projects will be discussed.

City staff member, Samantha Shearer, is now on maternity leave. The mayor informed Council of the current, heavy workload and asked Council for support.

There was brief discussion of the upcoming, August 29, 2022 joint meeting of the city and the Cascade Rural Fire district that will be held at City Hall at 6 pm.
