100 (ish) YEARS AGO Board of Village Trustees, Cascade, ID

February 7, 1918 - It was moved by Logue that the chief of police be instructed to see that all dogs in the village be tied up until further notice. Carried.

January 24, 1919 - Moved & seconded instructing the city attorney to draft an ordinance granting permission to picture shows and theaters to open on Sunday.

December 13, 1920 - On motion that an ordinance be drawn to change the time from Pacific to Mountain Time. Carried

September 4, 1923 - On motion to dispense with the services of the Marshall for the balance of the season.

October 2, 1923 - On request that the land known as the old base ball grounds be with drawn from taxation by the Village Board of Trusteees for the erection of a large Saw Mill by H.K. Allman,

Guy Mains and other five visitors present.



#### Cascade City Code (7-2-2)

limits parking of motor vehicles on any street or alley within the City for a period of no longer than two (2) hrs.

It is the responsibility of the Owners/Occupants of businesses fronting Main St. to remove snow, slush and mud from the sidewalks within 24 hours of occurrence.


