Duffers Paving Project

Council member Rachel Huckaby

Q. Council member Rachel Huckaby asked why RAP is not acceptable for this project? And, how is the process completed?

A. City Engineer, Trevor Howard, explained how recycled asphalt is applied and during warm weather so it will set. He further explained how the bid requests for hot mix were sent to the same bid list as the earlier, RAP bid request.

Council member, Denise Tangen stated to Council that two options that exist, RAP or Hot Mix. Council can do RAP next spring/summer so it will heat up and set properly; OR Council can do the Hot Mix now.

Council member, Rachel Huckaby is not in favor of asking residents to participate in sharing the cost and she is not a fan of spending for than the \$100,000.00 that was budgeted.

Council member Tangen feels that the “Duffers project” will hold up through the winter (for application of RAP next summer).

The City Engineer does not feel recycled asphalt (RAP) this time of year is a good use of money.

City Attorney, Dan Goodman was asked if backing out of the Granite contract for the RAP would pose a problem. He commented that the Granite Contract for RAP reflected a project completion by 10/1/23. They are in non-compliance of the contract – so, there is no issue there.
