**How to fill out your LOT Voucher**

Reporting Period will be the first of the month through the last day of the month. **Remittance of your LOT revenue is due on the 20th of each month along with a copy of your Idaho State \* Tax Return. \* If you file quarterly with the state; copies of the state return can be submitted at the end of the quarter. However, monthly remittance of LOT to the City of Cascade is required.**

For temporary vendor permits, your tax is due on the 20th day of the month following the last day of the event.

Retail Sales the amount for line 1 should be the same as on your total state sales tax form 850, Idaho sales/use tax. the amount for line 2 should be for **the sale of a single item \$1,000.00 and over.**

Lodging/Occupancy Related Sales the amount for line 5 should be the same as on your state sales tax form 1150, travel/convention tax. the amount for line 6 should be for **a single day occupancy rate** charged at \$1,000.00 and over.

Event Admissions/Fees Collected the amount for line 9 should be for qualifying admission, participation or spectator fees collected. the amount for line 10 should be for **a single admission, participation or spectator fee** of \$1,000 and over.

If you have no sales to report enter -0- on the appropriate line and submit a LOT voucher for "Zero" sales.

Submitting Your Payment Sign, attach copies of the appropriate state tax form/s and remit payment to the City Clerk's office.
