**PUBLIC COMMENT** 

Doug Trosky, 107 W. Market St.

Doug suffered a dog bite. As a lack of code enforcement for loose dogs; no proof of rabies vaccinations, and no Vly Cty Sheriff's enforcement nor call back regarding the bite, he feels that he has no recourse. Doug now has a \$4,000.00 medical bill for the rabies shots series as no record of rabies certification was on file. When he inquired, the Sheriff's department said they

Council reported that they only want three of the four trees marked by the City Engineer. Council member Tangen reminded Council that the letter to Palooza to replace their tree as originally agreed needs to be sent out.

This will be tabled until the end of the meeting. Council will walk downtown toward the end of the meeting.

#### AB 25-85 SUB 22-02 Raven Ridge Subdivision, Final Plat Approval (Action Item)

Staff Report: presented by Trevor Howard who summarized the history of the project. Not all of the

Construction has been completed and there is grading, and road base to be completed, and

setters to be installed.

Fire Chief Hull has fire hydrants that need to be tested prior to approval.

Jason Metz of Public Works wants the setters to be in prior to any people moving into the subdivision; otherwise all water will need to be shut off to all residents.

City Engineer, Trevor Howard, reminded Council that the pre-pay of (40) SAFS must received prior to any of this work.

No occupancy permits will be issued prior to these conditions being completed.

Council can approve as is or hold approval until these conditions have been met.

Darryl Shepard added that there is NO parking on the streets and the appropriate signing must be installed prior to his approval.

# Developer:

Cody Draper presented the status of the Raven Ridge project. He reiterated the project changing from (34) lots to (49) lots. There is a contract with the West Central Housing Trust. He has worked with the County Commissioners to get to final plat as soon as possible. Hence, he is seeking approval to begin building permits with the City of Cascade.

Cody has an active bond (financial guarantee) that if he were to leave the project, the City would have enough monies to complete the project.

Water and Sewer lines have been tested by City Engineer, Trevor Howard and they have passed.

It is the intention that ALL setters be installed prior to residents moving in. Cody currently has staff working on installation of the (40) pre-paid setters and anticipates 4 to 5 days to complete installation.

Cody would like to know when he can pre-pay the remaining (19) water credits. The City Engineer does not anticipate that these will be available until 2027. Payment will not be made by Cody Draper until that time.

As the bond financially guarantees the project, Cody is seeking approval of the final plat with conditions in order to meet the West Central Housing Trust deadline, record the final plat, and begin the submission of building permits on this project.

No homes will be connected to water until all (40) pre-paid SAFS are installed. The goal is to put (35) homes into Raven Ridge this spring and summer.

## Council Q & A

Denise Tangen is hesitant to approve the final plat without conditions. She is looking for a list of what remains to be done and make sure it is done.

Rachel Huckaby asked specifically what the conditions are that need to be met.

Denise Tangen asked for a guarantee that if the project is bonded that all conditions will be met.

The bond sufficiency to complete the project is \$588,895.00 which is sufficient per the City Engineer, Trevor Howard.

Jason Speer requested that items outside of the existing DA be met.

Trevor Howard listed the conditions that he would like to see

DA recorded on the plat.

Address CRFPD's Chief Steve Hull request that the minimum of twenty (20) unobstructed feet is reflected on the plat.

The installation of all (40) setters must be recorded on the plat.

Surveying the lots for identification (per state code) recorded on the plat.

All hydrants must be brought up to code and recorded on the plat.

Certificates of Occupancy will not be given by the Building Inspector until criteria are met.

Motion by: Denise Tangen approve the final plat of Ravens Ridge subdivision including the conditions

with Staff comments including but not limited to the DA on the plat, notes for Cascade Rural

Fire District, driveway notes and signage.

#### AB 25-87 Lease/purchasing for generator and Ventrach

(Action Item)

These lease/purchasing rates were shopped the City Treasurer, Keith Latimer. The first lease payments will not be due until May 1, 2026 with the exception of a payment toward interest by November 1st of 2025. Both leases do not have an early payoff penalty. The monthly payment on both pieces of equipment combined with be in the \$5,000 range. The rate that has been locked is 5.85%.

Rachel Huckaby has a question for Jason Metz about the Ventrach. She asked for clarification of what was included in the quote. Jason Metz reiterated that the quote includes the Tractor, cab heater, plower, snowblower, broom and mower deck are included. The unit is 4' wide and can be driven down the sidewalks.

Water meters have been "drive by" tested. (453) of the (667) meters read successfully. The others need to be programmed to read in the "thousand gallons".

The Mayor reported that in the original project (approximately 2007) several water users were billed for 1" meters when 2" meters were installed.

The camera for the waste water lines and the storm drains has been received. A test run has already been successfully completed.

Motorcycle rider from Boise to McCall (Poker Run) was asking permission if they could have a "Poker Stop" in the City of Cascade during the 4<sup>th</sup> of July weekend.
