1 - ADMINISTRATIVE

Permits The City Clerk's office is hereby authorized and directed to issue not more than six food vendor permits and occupy space on East Market Street between Main Street and East Service Way during City/ approved and/or sanctioned special events in numbered spaced provied by the Clerk's office.

Food Vendors must provide certification of Central District Health Department and CRFPD, (Cascade Rural Fire Protection District) approval Vendor's facilities prior to the issuance of a permit therefore. Permits may be issued for 1,2,3, or 4 days. All fees must be paid prior to the issuance of the permit. Hours available for operation shall be from 9 o'clock a.m. to 12 o'clock midnight of the same day. All of the vendor's facilities shall be removed and premis completely cleaned by 9 o'clock a.m. of the day after expiration of the permit. USE VENDOR RULES SHEET
